The regular meeting of the Board of Directors of Community Living Alternatives, Inc. (CLA) was called to order at 10:08 am by the Board President, Mr. Ken Dwenger. A quorum was present.

Minutes of December 3, 2024

MOTION: Ms. Shari Janata moved to approve the minutes of December 3, 2024. The motion was seconded by Ms. Margaret Dominguez. The motion was approved by unanimous voice vote.

Financial Statements for September, October, and November FY 2024-25—Ms. Betty Piperato Ms. Betty Piperato presented a synopsis of the September, October, and November financial statements. September had a net gain of \$3,423.68 for the agency and a net gain of \$11,131.34 for the Day Program. October had a net gain of \$1,509.23 for the agency and a net gain of \$166.21 for the Day Program. November had a net gain of \$917.71 for the agency and a net loss of (\$3,945.79) for the Day Program. For the year-to-date fiscal year, the agency had a net loss of (\$11,299.50) including a net loss of (\$1,323.05) for the Day Program.

For the year-to-date 2024-2025 fiscal year, the agency is doing better than budget by \$7,787.15 for the agency with the Day Program doing better than budget by \$7,036.10.

MOTION: Ms. Buffy Fox made a motion to approve the financial statements for September 2024. The motion was seconded by Ms. Margaret Dominguez. The motion was approved by unanimous voice vote.

MOTION: Mr. Scot Lichty made a motion to approve the financial statements for October 2024. The motion was seconded by Ms. Margaret Dominguez. The motion was approved by unanimous voice vote.

Budget Projections—Ms. Betty Piperato

Ms. Betty Piperato said she had not gotten far enough in the December financial statements to present usable projections but did say that Day Program had received a \$30,000 donation in January.

Board of Directors Fiscal Policies—Ms. Betty Piperato

Ms. Betty Piperato presented the changes to the Fiscal Policies

Executive Director Update—Ms. Barbara Kenyon-Mohrlang

As of today, we are providing services to 32 individuals in our Residential Program. We will be adding one person to our Residential Program soon. We are providing services to 25 people in our Day Program which includes one new person since our last meeting.

Staff updates were provided. We need to fill one position at our day program.

Policies and procedures will continue to be updated based on the latest regulation updates from 12/30/2024 and reviewed at the next board meeting.

Changes were recently made to how Denver county rates are billed. This may have a negative impact on our income at CLASS day program.

Federal and state legislative updates were discussed including the potential for Medicaid cuts in the near future.

Information about the DD wait list that was presented to the Joint House and Senate Health and Human Services Committee on January 22 was reviewed.
